FINANCE REPORT – FOURTH QUARTER YEAR TO DATE (JULY – JUNE 2021)

Income for the year totaled \$101,486 with expenses of \$94,129. Sixty-eight (68) % of our income for this period was generated from our educational meetings including our virtual annual meeting. Elisa Pelchat and our Education Committee, chaired by Melissa Robert, did an amazing job of transitioning to all virtual meetings and presenting the membership with a number of options for education. Additionally, thirty-one (31) % of our income came from AHIMA member rebates. Fifteen (15) % of our expenses are from educational programs due to hosting all virtual meetings this year. The remainder of expenses are due to administrative costs, including the cost for our virtual platforms (MemberClicks and Engagez). As of the end of June,

MaHIMA has \$116,253 in assets with seventy-three (73) % (\$85,415) in our investment account for reserves. The MaHIMA board has approved the FY 2022 budget which will be presented to the membership at the Fall business meeting for final approval.
